Message from the Executive Director & Chair of the Board

2022 was a year of challenges and accomplishments! We were able to accomplish great things and fulfill our mission even though the market was anything but great! Our goal is to fulfill our mission in everything we do. In 2022, we were blessed to award the following grants and scholarships:

- Grants totaling \$476,033.40 to our nonprofit community
- Scholarships totaling \$213,822.00 to 46 high school seniors and adult students to further their education
- Educational Improvement Tax Credit (EITC) Tuitions totaling \$194,309.00

The total amount distributed was \$884,164.40!! We were able to make a huge impact in our community!

We strive to promote informed philanthropy to increase and sustain charitable resources for the region. We do this by training nonprofit personnel to write effective grants and to generate donations from the supporters of each organization. We also provide leadership and build partnerships to identify and solve community issues. To that end:

- \$366,868.01 was raised by 34 nonprofit organizations during the Week of Giving which was held May 9-13, 2022
- \$20,005.18 was raised at the ACCF Golf Outing held on July 15, 2022
- \$150,450 was awarded at the Annual Dinner to 29 nonprofit organizations on October 11, 2022

We build a permanent endowment to help our donors create a legacy. We opened two new funds, the Bocinec and King Families Fund and the David C. Kohl Family Fund.

We could not do the work we do without a strong board of directors. We are very blessed that our founding board members' passion for doing great work in the community remains evident in our board today!

We are thankful for all of our donors, nonprofit organizations, and community members who are accomplishing great things as we work together! We look forward to the future and to continuing partnerships in our community!



- Nonrenewable

Applicant must:

- Be graduating or have graduated from a school in Armstrong or Clarion County
- Be studying one of the following fields: education, health/ medical, math and engineering, social and human services, technical trade
- Maintain minimum of 2.5 GPA
- Be accepted at an accredited 2 or 4 year college or university, community college or technical/business school

The Mable R. Slagle Nurses Training

Scholarship is for students enrolled in a nursing program at an accredited college/university in the US OR a student entering (first year) a nursing program at a recognized hospital training school. This is a

4-year renewable scholarship if student remains in satisfactory academic standing.

Mikaela Kottelich, a senior at Penn Trafford High School, was presented the Quality Life Services Healthcare Career Scholarship by ACCF Scholarship Coordinator, Dave McFarland.

The Quality Life Services Healthcare Career Scholarship

As a way of continuing that commitment to quality care and saying thanks to those who have helped to provide it, a scholarship has been established for current employees', their children and grandchildren who are pursuing a career in healthcare.

The Quality Life Services Healthcare Career Scholarship recipient must be a high school senior whose parent or grandparent is currently employed by a Quality Life Services Company (An employee of Quality Life Services may apply if that employee fulfills all other qualifications of the scholarship and is able to obtain a sponsor within the facility in lieu of a parent or grandparent. This would be someone in a supervisory role (i.e. Director of Nursing, Shift Supervisor, Director of the facility, etc.) One of the recommendation letters for this scholarship must be from this individual.

The recipient must be accepted full-time at an accredited two or four year college, university, nursing or vocational school in the United States with a declared major in a healthcare field employed by Quality Life Services and also must have attained a minimum 3.0 GPA.

Nedilynn Bowser from Lenape Vocational Technical School was awarded the Dr. John Garrott Memorial Scholarship. Presenting the award is Marion Garrott. Ms. Bowser was also awarded the Armstrong Concert Band Scholarship.

- High School Seniors and Adult Students
- Nonrenewable
- Approximately \$23,150 available, which will be split into multiple awards

Applicants must:

- Be a resident of Armstrong County or have graduated from Karns City High School
- · Be enrolled in the medical arts
- Be enrolled to become a medical professional at an accredited two or four-year college, university, nursing school, or medical school

Types of Funds Endowed (or Permanent) Funds

Organization Fund: A Charitable Organization Fund typically is established by a nonprofit 501(c)(3) organization or public charity (the "Agency") to provide support for Agency's exempt purposes, as recommended by the Agency. The Agency's recommendations must be advisory only, and the Community Foundation must be free to reject any recommendations.

Community Foundation Fund:

Also called an unrestricted fund, the Community Foundation Fund is established to provide support for general, unspecified charitable purposes at the discretion of the Community Foundation with no advice or recommendation from the Donor (or any persons designated by the Donor). Grants are made by the Community Foundation to address priorities in the community. The combined donations in this Community Foundation Fund allow ACCF the flexibility to respond to current and future needs and opportunities. **Designated Fund:** A Designated Fund typically is established to provide support for a specified public charity (e.g., the local women's shelter, hospital, or arts organization), with no future advice or recommendations from the Donor (or any person designated by the Donor). Grants are made annually, directly to the organization. Can be used by a donor to provide support forever to a cherished organization, church or other nonprofit.

Donor Advised Fund: A Donor Advised Fund typically is established to provide support for various charitable and similar exempt purposes recommended by the Donor or persons designated by the Donor to advise the Community Foundation. The recommendations must be advisory only, and the Community Foundation must be free to reject any or all recommendations. Allows the donor to be involved in grant recommendations and to support a variety of organizations. Due to tax law, no grants from donor advised funds may go to individuals, or to benefit an individual. **Scholarship Fund:** A Scholarship Fund typically is established to provide education scholarships to individuals. The donor (or persons designated by the Donor) has the option to be involved in the selection process for recipients.

Accessible fishing area established in Brady's Bend

A new accessible space for fishing has been created in Bradys Bend Township, as part of a project spearheaded by local disability awareness advocate Denny Markel.



Denny, an East Brady area native, was diagnosed with Duchenne Muscular Dystrophy and has been using a wheelchair since the age of nine.

Denny applied for a grant through the Armstrong County Community Foundation to create an accessible space for fishing at the pond.

The Community Foundation is approved through the Educational Improvement Tax Credit (EITC) program to accept donations from businesses that are approved by the Pennsylvania Department of Community & Economic Development (DCED).

What this means is that the approved businesses may contribute to the Community Foundation; and in turn, the Community Foundation awards scholarships to students wishing to attend private or faith based schools for Pre-K and K-12.

What is the advantage?

A business may receive a tax credit equal to 75 percent of its contribution to the Community Foundation up to a maximum of \$750,000 per taxable year. The tax credit may be increased to 90 percent of the contribution made, up to a maximum of \$750,000 per taxable year, if the business agrees to provide the same amount of contribution for two consecutive years.

What is the process for a business to receive the tax credit?

A business must apply to DCED for the tax credit. Tax credits are awarded on firstcome, first-served basis starting on the first day of the new fiscal year. Businesses can download an application at

www.newpa.com/eitc. After approval by DCED, a business must make its contribution to an approved Scholarship Organization(s) within 60 days. Once the business receives confirmation of their donation and sends that into DCED, the tax credit will be awarded.
